The New Jersey State League of Master Plumbers, Inc. was formed in 1930 to protect the plumbing industry *and* New Jersey consumers.

A non-profit corporation was filed on February 24<sup>th</sup>, 1931. For over the past 78+ years, the goal of the State League has been to promote the integrity of our profession, and protect the standards of our industry and licensing.

The League now has over 1,100 members statewide, serviced by over 30 State League Local Associations. In recent years, the plumbing industry has undergone significant changes, i.e. the type of pipe and other materials we use, advancements in heating technology and, most recently, the change in water heaters. Along with these equipment and material changes, our industry also experienced changes in our Plumbing Code. Our Local Associations are effective in keeping its members informed of these changes and allow product representatives to present and demonstrate new equipment and technology. This information is important to our success as business people.
